No.GG/111/PST/102013/683/C:- In exercise of the powers conferred by clause (u) of sub-section (1) of section 2 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (46 of 2023) in its application to the State of Gujarat, the Government of Gujarat hereby amends the Government Notification, Home Department No.GG/14/PST/102013/683/V, dated the 18<sup>th</sup> January, 2014, as under:-


